Dissertation Abstract

Side Effects in Medicine: Definitions & Discovery

Side effects are ubiquitous in medicine but are underexplored in theoretical examinations of science and medicine. This is striking since researchers often appeal to side effects to critique many aspects of modern medicine from the technological to the epistemological to the social and ethical. Moreover, definitions of 'side effect' given by health authorities like the CDC, FDA, and WHO differ. Considering this, I argue for a novel account of medical side effects that fulfils our commonplace intuitions in everyday practice while avoiding counterexamples that befall existing accounts. I argue that side effects are a specific species of treatment outcomes that are related but distinct from adverse events, adverse reactions, and placebic effects insofar as they differ intentionally and causally.

After discussing what side effects are and how they differ from other treatment outcomes, I turn to the social and ethical issues with the discovery process. Many side effects are not discovered until after market access or in the clinic. Post-market drug surveillance or 'pharmacovigilance' techniques like 'phase 4' trials blur the line between exploration and confirmation in science, or so I argue. I also show how other pharmacovigilance methods like reporting to regulatory bodies are constrained by normative judgments about evidence quality that are rooted in medical education and medical institutions. Finally, I offer a pragmatic, bioethical, and social-epistemic framework to evaluate proposals for patients to be more engaged in the side effect discovery process or medical 'citizen science.' My research engages with scholars based in theory and practicing clinicians alike and shows how side effects offer a vantage point into the linked issues of risk, values, medical education, and patient engagement in contemporary medical science.
